#### **ORDER**

The provisional seniority list of officers in the cadre of Deputy Director in PB-3 Rs. 15,600-39,100/-with Gr. Pay Rs. 5400/- upto the vacancy year 2010-11 was issued on 28.06.2016 and errors and objections, if any, to this provisional seniority list were called for within 30 days from the date of issue of the said seniority list.

In response to the above circulation, 26 officers had filed their objections. These objections were carefully examined by me in accordance with extant instructions of DoP&T. Accordingly, I, Raj Kumar, Director General, ESIC dispose off these objections by my considered decision as follows:-

1	Vimal Rawat and Chandra Bhanu Jha	<b>ISSUES RAISED:</b> Recast the seniority list on the same analogy as applied in the cadre of SSO, instead of placing entire panel of DR against a single vacancy/ recruitment year, these may also be broken and placed as per the vacancy earmarked for DR in these years, without breaking the order of merit in the panel.  Being two different cadres in all respect, separate seniority list may be prepared for DD (Admit) and DD (Fin.).
		Thereafter, the two different seniority lists may be interpolated for preparing "common select list" for promotion in higher cadre. It must be interpolated in the same ratio on which vacancies in these respective cadres were identified, earmarked and then indented to UPSC.
		<b>CONSIDERED DECISION:</b> The seniority lists of SSO's and DD's have been prepared by following DoP&T guidelines issued from time to time. As per DoP&T Instructions dated 11.11.2010 "The relative seniority of direct recruits and of promotees shall be determined according to the rotation of vacancies between available direct recruits and promotees which shall be based on the quota of vacancies reserved for direct recruitment and promotion respectively in the Recruitment Rules."
		The promotee and DR (Fin./Admn.) were interpolated in quota of vacancies reserved for direct recruitment and promotion in Recruitment Regulations of Deputy Director i.e. 50:50. The entire panel of DD(Fin.) is placed en-bloc above the DD(Admin) panel in accordance with DoP&T instructions dated 11.11.2010 which states that " <i>The relative seniority of all direct recruits</i> "

		is determined by the order of merit in which they are selected for such appointment on the recommendations of the U.P.S.C., persons appointed as a result of an earlier selection being senior to those appointed as a result of subsequent selection." The select panel of DD(Fin.) is received earlier than D.D.(Admin.) from UPSC. However, year wise panel was not received for either DD(Fin.) or DD (Admn.) The seniority of Deputy Director (Fin.) and Deputy Director (Admn./Ins./Trg.) list have been drawn up as per DoP&T Instructions No. 22011/5/76-Estt. Dated 24.06.78.  As per RR of Regional Director Gr. B/Joint Director, there is only one feeder cadre that is Deputy Director. Therefore, the concept of preparation of combined eligibility/selection list is not applicable.
2	Dharamvir Singh	<b>ISSUES RAISED:</b> In the instant case all candidates belonging to reserve panel has been placed enblock below select panel. Shri Rama Rao Malla, who is at Sr. No.178 in the seniority list has secured 118 marks, while he has secured 119 marks in the examination, there is no delay in joining on his part. He should be placed above Sh. Rama Rao Malla.
		His selection can neither be construed as a subsequent selection nor additional direct recruitment selection.
		CONSIDERED DECISION: As per DoP&T Instructions "The interse seniority of candidates nominated from reserve panel will be fixed as per consolidated merit given by UPSC/SSC/recruiting agency"  Accordingly, the seniority has been assigned to the candidates of reserve panel as per consolidated merit list received from UPSC and not as per the rank secured in the examination.
3.	Amarnath Tiwari	<b>ISSUES RAISED:</b> (Placing the DD(F) batch enbloc senior to that DD(A) batch is not justified as the date of requisition was same.
		The selected candidates will be entitled to be assigned seniority with reference to the recruitment year (in which the requisition of vacancies was made).
		It may be noted that Supreme Court in its judgement has categorically stated u/c 22(b) that the date of joining would not be a relevant factor for determining seniority of direct recruits. It has further clarified that concept of initiation of recruitment is equally applicable to direct recruits and promotes.
		The seniority of DD(A) and DD(F) is recruited through UPSC albeit through different sources, may be fixed in the ratio of declared vacancies, the date of requisition being same, i.e. in the instant case it should be in the ratio of 71:17 (i.e. 4:1).
		CONSIDERED DECISION: The reply has already been given at Sl. No. 1.
4.	N.N. Singh	<b>ISSUES RAISED:</b> The DPC of UPSC wrongly assessed me fit for promotion against year 2010-11, whereas I was eligible for promotion against vacancy

year 2008-09.

The DPC filled only 26 posts and kept 21 posts of General category, 14 of SC category and 10 ST category as vacant on the ground that sufficient eligible officers were not available and subsequently the DPC has also considered me fit for promotion in year 2003-04. My date of promotion should have 2008-09. I was promoted against regular vacancy of year 2008-09, which is grossly incorrect.

Dy. Director (Fin.) and Dy. Director (Admn.) are two different cadres governed by two separate Recruitment Rules.

I would have been proposed in the years prior to 2008-09. But administration preferred to deny us representation in the cadre of DD(Fin.) to delay our promotion and give undue benefit to direct recruitment DDs.

**CONSIDERED DECISION:** The seniority has been assigned as per recommendations of DPC/UPSC and in accordance with DoP&T instructions dated 07.02.86, 03.07.86 and 04.03.14.

Haridas Menon

**ISSUES RAISED:** The draft seniority of DDs published on 28.6.16 in which my position shown at Sl. No.117. My date of promotion and assuming charge to the cadre of DD should actually be 1.7.2010 for the vacancy year 2010-11. As per model calendar for DPCs, contained in DoPT OM NO.22011/9/98.Estt.(D) dated 8.9.1998, the DPC for the vacancy year should have been completed before 1.4.2010 for the vacancy year 2010-11.

Persons appointed as a result of an earlier selection being senior those appointed as a result of subsequent selection. Since the initial promotion are made on temporary/ adhoc basis.

The relative seniority of direct recruits and of promotes shall be determined accordingly to the rotation of vacancies between direct recruits and promotees which shall be based on the quota of vacancies reserved for direct recruitment and promotion respectively in Recruitment Regulations. The additional direct recruits selected against the carried forward vacancies of the previous year would be placed enbloc below the last promotee ( or the direct recruit as the case may be) in the seniority list based on the rotation of vacancies for that year.

Thereafter appointees are placed enbloc from Sl. No.81 to 110 even though there are 130 promoted in the list compared to 123 appointees totaling to 253. The last seven promotees alone need to be kept enbloc below 123 promotees and 123 appointees placed in 1:1 ratio.

As per illustration in DoPT OM dated 3.7.1986, all the promotes and direct recruit appointees completed on or before 31.3.2011 to be placed according to their quota and the vacancies intended for direct recruitment remain unfilled during 2010-11 filled during subsequent year shall be merged with subsequent

year promotees.

The direct recruit appointees at even SI. No.24 to 78 (38 appointees) are not appointed during the Recruitment year 2009-10. Hence they should be placed below the promotees No.40 at SI. No.79 Mahenderkumar. In other works, the 40 promotees and 11 appointees for the year 2009-10 should be rotated by placing 1:1 ratio starting with promotes up to SI. No.22. Thereafter, the 29 to 79 (29 promotees) to be kept enbloc after SI. No.22.

Thereafter, the 48 promotees in HQ Order No.125 of 2012 dated 3.8.2012 who were promoted for the year vacancy year 2011-12 and no direct recruitees appointed during the vacancy year 2011-12.

**CONSIDERED DECISION:** Service rendered on adhoc basis does not count for seniority purpose.

An officer becomes regular only from the date of DPC/date of assumption of charge to the promoted post on the recommendations of DPC and not from the date he is due for promotion as claimed by Sh. Menon.

#### 6. Baldev Raj

**ISSUES RAISED:** My position shown at Sl. No.213 below the officers who joined much later than me which is against the instruction No.20011/1/2012-Estt(D) dated 4.3.2014 read with the DoPT instructions dt.7.2.86. in this instruction it is stated interalia that rota quota rule will be applicable to the extent of direct recruits available in that particular recruitment year and rest of the vacancies is carried forward.

The direct recruitees joined in subsequent years 2012/2013/ 2014/ 2015 cannot be considered for recruitment year 2011 for rota quota as the instruction mentioned ibid.

The apex court in their various judgments clearly stated that an officer regularized before the direct recruit cannot be made junior to a direct recruit.

I was promoted as regular DD vide HQ order No.29 dated 24.3.2011 on the recommendation of DPC/UPSC, my seniority should not be fixed below the recruitees of the year 2015, 2014, 2013 and 2012.

By proposing to place all those DDs who are still drawing Rs.5400/- GP above the officers placed in the STS of Rs.6600/- GP is unjustified and will deprive me of my further promotion prospective, despite the fact that I have rendered more than 25 years of service to the Corporation.

**CONSIDERED DECISION:** Seniority is not determined from the date of joining. It is determined against the vacancy year in which one has been recruited.

Grant of STS is not related to seniority. It is given only after completion of 4/5 years of regular service in Deputy Director Cadre.

#### 7. Kashi Prasad Pandey

**ISSUES RAISED:** Sh. Sanjay Kr.(Sl.No.150) was selected from the reserve panel of DD(Fin.), he should be placed below the entire batch of direct recruits of DD(A) batch of vacancy year 2010-11 who were selected from the original list. Hence the position of Sh. Sanjay Kr. may be revised in the seniority list.

In the provisional seniority list, all the direct recruit DD(Fin.) of the vacancy year 2010-11 have been placed enbloc senior to the direct recruit DD(A) of the vacancy year 2010-11 based on the earlier date of declaration of result/ earlier date of forwarding of panel of candidates by UPSC/ earlier date of joint of DD(Fin.) batch which is against the law on seniority as propounded by Hon. Supreme Court.

It would suffice if action has been initiated for direct recruit vacancies, within the recruitment year in which the vacancies had become available.

As such initiation of action for recruitment within the recruitment year would be sufficient to assign seniority to the concerned appointees in terms of the "rotation of quotas" principle, so as to arrange them with other appointees from alternative source, for the vacancies of the same recruitment year.

If the process of recruitment has been initiated during the recruitment year (in which the vacancies have arisen).

While actually the earlier selection has to be understood as early initiation of process of recruitment in view of DoPT clarification dt. 29.2.2000 (regarding inter-se seniority of direct recruits and promotee DDs)

As per the information available , the date of sending requisition of UPSC for filling up of vacancies for both DD(A) and DD(F) was 30.11.2010.

Thus earlier declaration of result of DD(Fin.)/ earlier sending of panel of candidates by UPSC/ earlier joining of DD(F) batch will not alter the seniority position since the seniority of direct recruits is based on the chronology of requisition sent to UPSC. Hence, as the post of DD(A) chronologically came first in the advertisement published by UPSC and the vacancy number was also earlier.

**CONSIDERED DECISION:** Seniority has been assigned strictly in accordance with the panel received from UPSC.

#### 8. Damodar Prasad Sharma

**ISSUES RAISED:** The seniority list if not revealing year wise position of candidates of promotion quota as we as direct recruitment quota. By issuing a consolidated list of many years till year 2010-11 the minute details which were needed to be examined were concealed. The seniority list should have been separated year-wise.

The DPC filled only 26 posts and kept 21 posts of General Category, 14 of SC category and 10 of ST category as vacant on the ground that sufficient eligible officers were not available. Whereas it is confirmed from records that sufficient number of officers were available in the cadre for promotion including myself.

Had all the vacancies filled in year 2008-09 the vacancy position for year 2009-10 would have been as Gen 8, SC.2.

Post of DD(A) and the post of DD(F) are different cadres governed by two separate recruitment rules and hence both the cadres should have their separate seniority lists.

I was eligible for promotion to the post of DD(F) as per its recruitment rules. Since 50% of the post i.e. 32 posts were filled by DR remaining 32 posts of promotion quota for the post of DD(F) would have been filled in time I would have been promoted in year prior to year 2008-09. But administration preferred to deny us representation in the cadre of DD(F) to delay out promotion and give undue benefit of direct recruitment DD.

CONSIDERED DECISION: As per para 2.2.1 of DoP&T O.M. dated 11.11.2010 "Where promotions to a grade are made from more than one grade and quotas have been laid down for each feeder grade, the eligible persons shall be arranged in separate lists in the order of their relative seniority in their respective grades. The officers in each grade, assessed as fit by the Departmental Promotion Committee shall be interpolated in the ratio prescribed for each grade in the recruitment rules for the post."

As per RR of Regional Director Gr. B/Joint Director, there is only one feeder cadre that is Deputy Director only. Therefore, the concept of preparation of separate seniority list for DD(F) and DD(A) is not applicable.

9.	Aruna Sharma	<b>ISSUES RAISED:</b> Seniority not drawn as per DOPT instruction dated 04.03.2014 which itself states the principles laid down therein will be effective from 27.11.2012 i.e. date of Supreme Court Judgement in case of Sh. N.R. Parmar.
		The provision of DOPT OM dated 07-02-86/3/07/86 remain applicable unaltered till the revised instruction application from 27.11.12.
		This implies that seniority would have to be decided under DOPT OM dated 07-02-86/3-7-86 till 27-11-12.
		Promotee officers in the list from 1 to 29 were given regular promotion against the vacancy year 2005-06 and 2007-08 and direct recruits appointed in 2009 and 2010 assigned seniority alongwith those officers of vacancy year 2005-06 and 2007-08.
		<b>CONSIDERED DECISION:</b> The referred DoPT instruction is also applicable in her case and seniority has been prepared accordingly.
10.	Roopa Banerjee	<b>ISSUES RAISED:</b> Recruitment year would be the year of initiation. Initiation of recruitment process would be date of sending of requisition.
		The date of requisition being same in case of DD(F) and DD(A) recruited through different alternative source albeit through UPSC, the weightage has to be equally given to both the sources/batches and their seniority should be fixed in the ration 4:1.
		<b>CONSIDERED DECISION:</b> The seniority of DD(A) and DD(F) recruited through UPSC cannot not be fixed in the ratio 4:1, since there is no ground/instructions/guidelines for doing so.The seniority list has been prepared as per extant DoP&T instructions.
11.	Ratnagiri S	<b>ISSUES RAISED:</b> Since Shri Sanjay Kumar (Sl. No. 150) was selected from the reserve panel of Dy. Director (Finance) he should be placed below the entire batch of direct recruits of Deputy Director (Admn.) batch of vacancy year 2010-11 who were selected from the original list. Hence, the position of Shri Sanjay Kumar may be revised in the seniority list accordingly.
		Dy. Director (Admn. etc) were given seniority over Dy. Director (Finance) even though the panel of candidates for Dy. Director (Finance) recruits joined earlier when compared to date of forwarding of panel of candidates for Dy. Director (Admn. etc) by UPSC (date 17-09-2000) and subsequent joining by Dy. Director (Admn.) Recruits. This was done on the premise of early initiation of recruitment process for Dy. Director (Admn. etc) (requisition sent to UPSC on 28-11-2000) compared to Dy. Director (Finance) (requisition sent to UPSC n 11-01-2001) based on DOPT clarification dated 29-02-2000 that early selection is to be understood as early initiation of process of recruitment.
		In the advertisement No. 23/11 issued by UPSC published in Employment

		News dated 10-16, December, 2016 (copy enclosed), the post of 36 Dy. Director (Admn etc) was shown at Sl. No. 1 against vacancy No. 11122301410 by UPSC while the 20 posts of Dy. Director (Finance) was shown at Sl. No. 2 against vacancy No. 11122302410 by UPSC. Thus, chronologically, the post of Dy. Director (Admn.) comes first and vacancy number was also earlier 11122301410 compared to Dy. Director (F) at Sl. No. 2 and subsequent vacancy number 11122302410 even though the requisitions for both the posts were sent to UPSC on 30-11-2010 and both the posts were advertised by the UPSC on same date.  CONSIDERED DECISION: Seniority has been assigned strictly in accordance with the panel received from UPSC.
12.	Arul Raj M.	<b>ISSUES RAISED:</b> Separate cadres should have been separate seniority list. Both these cadres have different recruitment regulations and different selection method/process.
		DOPT OM dated 11 <sup>th</sup> November, 2010 where two different cadres have common promotional cadres, seniority list of different cadres can only be interpolated for preparing a combined select list for promotion. Preparing combined seniority list for these cadres is totally uncalled for and not in accordance with rule position.
		The entire Dy. Director (F) have been placed enbloc above the Dy. Director (A) panel citing the plea that both are same cadre and Dy. Director (F) panel have been recommended by UPSC at an early date. Recast seniority list on same analogy as in case of SSO.
		Being two different cadres in all respect, separate seniority list may be prepared for Dy. Director (A) and Dy. Director (F).
		Thereafter, the two different seniority list may be interpolated for preparing common select list for promotion in higher cadre. It must be interpolated in the same ration on which vacancies in these respective cadre were identified earmarked and then indented to UPSC.
		CONSIDERED DECISION: The reply has already been given at Sl. No. 1.
13.	Bhaskar G	ISSUES RAISED: Reserve Panel candidates not placed as per rules.  CONSIDERED DECISION: Seniority has been assigned strictly in accordance with the panel received from UPSC.
14.	A.K. Ranga	<b>ISSUES RAISED:</b> Combined seniority list of DD(Admn) & DD(Fin) with two separate RRs recruitment/selection method/process. Single seniority list of two separate cadres not correct. Hence may be redrawn in the light of DOPT O.M. No. 20011/1/2015-Estt (D) dated 11-11-2010.
		DD(F), batch has been enbloc above DD (Admn) 2010 batch, while above

		same date of initiation request for drawing two separate seniority lists and thereafter interpolated for preparing common list in the same ratio in separate cadres were identified, earmarked and requisitioned to UPSC.  CONSIDERED DECISION: Reply has already been given at Sl. No. 1.
15.	K. Raghuraman	<b>ISSUES RAISED:</b> Single / combined seniority list have been made for DD(Admn.) and DD(Fin.) despite the fact that these are separate cadre with distinct Recruitment Regulations prescribing entirely different methods of Recruitment and ought to have separate seniority list. The seniority list of these cadres can only be interpolated for preparing a "combined select list" for promotion. Preparing a combined seniority list for these cadres is erroneous and may be rectified.
		I had joined the services of ESIC on 19-01-2001 as Insurance Inspector / Manager Grade – II and was relieved on 14-09-2010 (AN) I had without break joined in the cadre of Deputy Director on 15-09-2010 (FN). In view of the same, my date of joining in ESIC should be corrected as 19-01-2001(FN).
		CONSIDERED DECISION: Reply has already been given at Sl. No. 1.
16.	Saikat Mandal	<b>ISSUES RAISED:</b> Cited Hon'ble Supreme Court Judgement in the case of R.K. Botha vs N.R. Parmar.
		Enbloc placement of DD(F) batch over DD(Admn) not correct. Cited DOPT instruction. Seniority may be fixed in the ratio of 71:17 (i.e.) 4:1
		CONSIDERED DECISION: Reply has already been given at Sl. No. 1.
17.	S.V. YUVARAJ	<b>ISSUES RAISED:</b> 1. Sh. Sanjay Kumar at Sl. No. 150 who was appointed from the reserve list / panel of Deputy Director (Finance) and joined on 04/12/2014 has been placed above me in the draft seniority list. He should be placed below the entire batch of direct recruits of Deputy Director (Admn.) batch of vacancy year 2010-11 who were selected from the original list.
		2. In the provisional seniority list, all the Direct Recruit Deputy Directors (Finance) of the Vacancy Year 2010-11 have been placed enbloc senior to the Direct Recruit Deputy Directors (Admn. Etc.) of the Vacancy year 2010-11 based on the earlier date of declaration of result/earlier date of forwarding of panel of candidates by UPSC / earlier date of joining for Deputy Directors (Finance) batch.
		3. The date of sending requisition to UPSC for filling up of vacancies for both Deputy Director (Admn. etc.) and Deputy Director (Finance) was 30.11.2010 and both the posts were advertised by UPSC on the same date. Result for the post of Deputy Director (Finance) was declared earlier / panel of selected candidates were forwarded earlier by UPSC. Result for the post of Deputy Director (Admn. Etc.) was declared later / panel of selected candidates was forwarded later by UPSC and consequently Deputy Director (Admn. Etc.) batch

A

		joined later. Earlier sending of panel of candidates by UPSC / earlier joining of Deputy Director (Finance) batch will not alter the seniority position since the seniority of Direct Recruits is based on the chronology of requisition sent to UPSC. Chronologically to the post of DD(A) came first in the advertisement. Hence, DR – DD(A) may be placed enbloc senior to DR-DD(F).
		<b>CONSIDERED DECISION:</b> Seniority has been assigned strictly in accordance with the panel received from UPSC. Reply has already been given at SI. No. 1.
		Plea for the placement of DD(A) above DD(F) panel is devoid of merits.
18.	RAKESH KUMAR	<b>ISSUES RAISED:</b> Placing the entire panel of DD(Fin) en-bloc above the DD(Admin) panel, Treating both the cadre same.
		In ESIC both have different method of recruitment, Selection for the post of DD(Admn) is through written examination followed by interview. The accumulated vacancies of approx. 7 years were apportioned between these two cadres in a particular defined ratio. As per the DOPT O.M. No. 20011/1/2008-Estt.(D) dated 11 <sup>th</sup> November 2010, where two different cadres have common promotional cadres, seniority list of different cadres can only be interpolated for preparing a "combined select list". Preparing common and single seniority list for both the cadres is totally uncalled for and giving undue advantage to DD(Fin.) over DD(Admn.)
		Different rule positions have been applied for preparing seniority list of SSO and DD.
		Prepare a "Combined Eligibility List" for the purpose of promotion in the cadre of Joint Director, in a similar ways as it was done in the case of Central Excise and Custom as per the guiding principal of Hon'ble Supreme Court order dated 22.11.1996, in case where RR for the promotional post do not prescribed the ratio in which multiple feeder cadres was to be interpolated.
		CONSIDERED DECISION: Reply has already been given at Sl. No. 1.
19.	DEBABRATA PRAMANIK	<b>ISSUES RAISED:</b> Was declared regular in the cadre of Dy. Director from 26.7.12. Even in 2015 found place in the provisional gradation list. Direct recruit Dy. Directors have been placed en block before the promoted Dy. Directors which is against the norms of placement in the seniority list on 1:1 basis.
		<b>CONSIDERED DECISION:</b> Issues raised does not pertain to this seniority list.
20.	ARJUN CHATTER	<b>ISSUES RAISED:</b> Was declared regular in the cadre of Dy. Director from 21.3.2011, though Dy. Directors joining this organization even in 2015 found place before me in the provisional gradation list. Seniority list of Dy. Directors at the appropriate place.
		CONSIDERED DECISION: Seniority has been determined as per consolidated panel received from UPSC of DRs and select panel of promotees

		by following Rota/Quota.
21.	MANISH SHARMA	<b>ISSUES RAISED:</b> Provisional common seniority list for both DD(A) and DD(F) were published, vide HQ letter dated 29-01-16. Adhoc promotion of 5 DDs were granted. Out of these 5, one Shri Rajesh Kr. Is junior to me. This has created an anomalous situation and hurt to all those who are senior to them. Thus promotion order dated 29.1.16 is neither in the conformity with GOI instructions. On the issue nor as per the provision of the old RR for the post. The Admn. erroneously ignored the above provision and instead invoked the eligibility service of revised RRs. As a result, juniors were erroneously were promoted and seniors were ignored. He requested for retention of existing eligibility service as per DOPT OM dated 30.10.2010 and grant of promotion against the vacant post in JD to all eligible DDs who were holding the feeder cadre post on the regular basis on the date of notification of revised RRs. i.e. 8.11.13.
		CONSIDERED DECISION: Issue raised is not related to seniority list.
22.	SUNEEL KUMAR NEGI	<b>ISSUES RAISED:</b> Common seniority list have been made for D.D. (Admn.) and DD(Fin.) despite the rule in practice that separate cadres have separate seniority list. Both these cadres have different Recruitment Regulation and different selection method / process. Same rules have not been applied for preparing seniority list of SSO and DD. Present draft seniority list have resulted major loss to the panel of DD(Admn.) as compared to DD(Fin). The entire panel of DD (Fin.) have been placed en-bloc above the DD (Admn.) panel. The date of joining would not be a relevant factor for determining seniority of direct recruits.
		If the process of recruitment has been initiated during the recruitment year and the selected candidates joined in a further later year, the selected candidates will be entitled to be assigned seniority with reference to the recruitment year.
