The Departmental Promotion Committee was informed of the following
contained in the DPC guidelines, circulated by the Department of
and Training, vide their O.M. No. 22011/5/86-Estt.(D) dated

" 6.1.2. - The DPC enjoy full discretion to devise their own
methods and procedures for objective assessment of the
suitability of candidates who are to be considered by them".

" 6.1.3. - While merit has to be recognized and rewarded,
advancement in an officer's career should not be regarded as a
matter of course, but should be earned by dint of hard work,
good conduct and result oriented performance as reflected in
the ACRs and based on strict and rigorous selection process".

" 6.2.1(e) - The DPC should not be guided merely by the
overall grading, if, any, that may be recorded in the CRs but
should make its own assessment on the basis of entries in the
CRs, because it has been noticed that some times the overall
grading in a CR may be inconsistent with the grading under
various parameters or attributes".

The Committee was also informed that in accordance with the
contained in para 6.3.1 of the DOP&T O.M. No. 22011/5/86-
dated 10.04.1989, read with subsequent O.M. No. 22011/5/91-
dated 27.03.1997 and O.M. No. 35034/7/97-Estt(D) dated
08.02.2002, the bench mark for promotion in the present case is "Good".

The Committee was also invited to the instructions
in DOP&T O.M. No. 35034/7/97-Estt(D) dated 08.02.2002, which
provides that "the DPC shall determine the merit of those being
for promotion with reference to the prescribed bench mark and
grade the officers as "Fit" or "Unfit" only. Only those who are
(i.e. who meet the prescribed bench mark) by the DPC shall be
and arranged in the select panel in order of their inter-se seniority in
grade. Those officers who are graded "unfit" (in terms of the
bench mark) by the DPC shall not be included in the select panel.
There shall be no supersession in promotion among those who are
(in terms of the prescribed bench mark) by the DPC".

The Committee was apprised that taking into account the
guidelines, issued by DOP&T, as detailed above, the
in exercise of their constitutional functions as envisaged
320 of the Constitution took a conscious decision that an officer
at least 4 bench mark gradings out of the 5 ACRs, as prescribed by




The Departmental Promotion Committee, accordingly examined the muster Rolls of the eligible officers, and assessed them as indicated at Annexure I.






